Litters must be submitted within 18 months of whelping.

It is the responsibility of the breeder to transfer the puppy within fourteen days of disposition.

The pedigree must not be given to the new owner until it has been transferred in accordance with these SACA Rules.

NAME

- No more than 30 characters, including spaces and breeder's prefix.
- Refer to ANKC Regulations Part 6 for use of another prefix in the dog's name.
- Cannot contain numerals, apostrophes or hyphens.
- Duplicate names cannot be used with the same prefix.
- If your first choice name is refused and there is no second choice, a name will be selected for you.
- A name cannot be changed once registered

Tattoo/Microchips – Handwritten microchip numbers will not be accepted. Adhere sticker with 15-digit number or attach a copy of the microchipping certificate.

Register – (default Main) Limited register is for progeny ineligible for conformation exhibition, not entire, not to be bred or exported.

Note – All living progeny must be listed on this form.
