Dogs Imported from any country (except New Zealand) must provide the following: All pedigree dogs that are imported into Australia (including dogs whelped in Australia and previously exported from Australia) to be re-registered with ANKC Ltd must provide, at the time of registering the animal the following: 1. Proof of identification, i.e. microchip or tattoo. 2. Proof of importation, such as "health permit", "export permit" or "import permit". 3. Proof of Shipment from the country of origin to Australia such as transportation documents "Airway Bill". OR 4. DoA Quarantine Release form (2 and 3 above are not required if you have the DoA release). 5. An original Export Pedigree and Ownership Certificate (if two separate documents) indicating the Australian member's name and current residential address showing all registration numbers, titles granted and colours by the overseas body.

Dogs Imported from New Zealand must provide the following: 1. Proof of identification, i.e. microchip or tattoo. 2. Export Certificate provided by the New Zealand Ministry for Primary Industries. 3. Proof of Shipment from New Zealand to Australia such as transportation documents "Airway Bill". 4. An original Export Pedigree and Certificate of ownership, indicating the Australian member's name and current residential address showing all registration numbers, titles granted and colours by the New Zealand Kennel Club. The imported dog must be transferred to the new owner's name in the Country of residence prior to Export and re-registered by the ANKC Ltd State Member Body in which the registered owner resides.
