Entry Limits: Should balloting be required this will occur at D.G.K.&O.C. clubrooms on Wed 29th July at 11.00AM. Competitors will be notified.

Catalogues: Available on the Scent Work SA Facebook page 2 days prior to the event.

Prizes: Ribbons to all qualifiers and prize for 1st place.

Catering: No catering will be available at the grounds.

Hot Weather Rules, Extenuating Circumstances or the Extreme Weather and Safety Rules: If required the Dogs SA and ANKC hot weather rules for Scent Work will be applied. If cancelled due to the Hot Weather Rules, Extenuating Circumstances or the Extreme Weather and Safety Rules, no entry fees will be refunded.

Class Eligibility: It is the competitor's responsibility to enter the classes they are eligible to enter. Refer to 6.1 Titling Classes and 6.2 Progression through the Titling Classes of the ANKC Scent Work Rules (specifically 6.2.2 and 6.2.3) re eligibility requirements for entering trials.

Notes and other rules: The judge's decision is final: **Rule 10.1.3** - there shall be no training utilizing the Scent Work target odours on the grounds of a Dogs Australia Scent Work Trial, other than in the designated warm up area. Breach of this rule shall result in disqualification: **Rule 13.11** - there is to be no discussion of the searches until all competitors have finished the class. (thumbs up, thumbs down are allowed).
